Purpose

Cal ICH is providing this project setup document in partnership with Abt Associates ("Abt"), the technical assistance ("TA") provider for AB 977 implementation, as part of broader technical assistance efforts aimed at supporting grantees and HMIS Leads with AB 977 compliance. This document specifies the

entry format for HMIS data entry and describes the project setup requirements for grantees of these programs.

Additional support and technical assistance are available to HMIS Leads and CoCs to assist them in adding new projects and updating existing projects to comply with AB 977 requirements. Each HMIS Lead has been assigned an Abt HMIS liaison. HMIS Leads can reach out to their assigned liaison with any questions or for more in-depth TA via the AB 977 TA helpdesk at AB977_TA@abtassoc.com.

Overview of Project Setup and Data Entry Requirements

Grantees of the above named programs who serve people who are either at risk of and/or experiencing homelessness are required to comply with the HMIS project setup and data entry requirements set forth in HUD's <u>HMIS Data Standards</u> as well as the funding codes and grant identifiers (see <u>Table 3</u>) detailed in this document.

Project Setup

This section provides an overview of key Project Descriptor Data Elements (PDDEs) with data entry instructions specifically for projects that receive funding from the above-named programs.

Encampment Resolution Fund-Specific Setup

The Encampment Resolution Fund (ERF) program has a statutory requirement that grantees submit individual client-level data to Cal ICH for the purposes of research and evaluation (<u>HSC 50254(b)(3)</u>). To reduce the manual reporting required to meet this statutory requirement, starting with ERF-2-R, ERF projects must be set up in a way that allows Cal ICH to unequivocally identify in HDIS all the served clients from the designated encampment(s).

To meet this requirement, grantees must ensure that at least one HMIS project (or multiple projects when combined) used for ERF client services/activities is both (1) exclusive to only ERF clients (i.e. clients that are not from the designated encampment(s) are not also included in that HMIS project) and (2) comprehensive of all the clients served by ERF from the designated encampment(s). HMIS Leads can work with ERF2R grantees and Abt TA providers to ensure projects are set up correctly.

Organization Name: Cal ICH *recommends*, but does not require, that grantees creating new projects in HMIS create separate projects for each subgrantee to allow grantees and the state departments to monitor and ensure compliance of all subgrantees. This recommendation applies to both Cal ICH and CDSS programs. Projects funded by HCD or CCCCO programs should be set up as follows:

- HCD: The organization name should be the organization providing state-funded assistance or housing. Subrecipient or subcontractor organizations must create separate projects in HMIS. For recipients that are housing developers, the organization name in HMIS should be the name of the organization that will be entering the client data into HMIS. For example, many developers subcontract with nonprofit organizations to provide direct services or assistance to clients. If staff at the nonprofit service provider will be recording client information in HMIS for that project, the organization name should be the name of the nonprofit provider.
- **CCCCO**: The organization name should be the organization that will be entering the client data into HMIS. For colleges providing direct housing assistance, enter the name of the college. Subcontractors or partner organizations which are providing direct service must create separate projects in HMIS.

Continuum Project: Continuum Projects are projects within the geographic boundaries of the Continuum(s) of Care whose primary purpose is to meet the specific needs of people who are experiencing or at risk of homelessness by providing housing, shelter, and/or services. Most projects created under AB 977 should be set up as Continuum Projects (Continuum Project = "Yes"). Table 1 below shows which project types for which populations should be classified as Continuum or non-Continuum. If only some of the project's housing/services fall under the definition of Continuum Project, two separate projects will need to be created.

Projects that are dedicated and/or restricted to serving people *experiencing* homelessness should **always** be considered Continuum Projects. Projects that are **not** restricted to either people experiencing homelessness or at risk (e.g., general affordable housing developments that are frequently funded by HCD programs) are **never** considered Continuum Projects and can be excluded from HMIS.

Project Type: HUD-defined HMIS Project Types and examples of grant activities within each Project Type with the most applicable of the above-named programs are listed in <u>Table 2</u>. This is provided to assist HMIS Leads and grantees with determining the appropriate project type(s) and does not reflect an exhaustive list of project types and activities. In some cases, individual grantees may use their funding

² Note that grantees of some programs did not receive Continuum Project information in the tabular form shown here; however, Cal ICH guidance around the use of Continuum Project is the same across all programs.

³ HCD's MHP, NPLH, and VHHP programs fund general affordable housing projects that are not always restricted to people experiencing or at-risk of homelessness. HCD does not require HMIS entry for these projects, but it is optional. If HMIS Leads encounter other projects funded by other programs that are not restricted or dedicated to people experiencing or at-risk of homelessness, they should contact their Abt HMIS liaison to confirm whether HMIS is required.

Funding Sources: Grantees must enter the standardized funding source code provided by Cal ICH (see <u>Table 3</u>) to allow state departments to track compliance with AB 977. These codes will also need to be updated for existing projects in HMIS.

- Funding Program: "Local or Other Funding Source (Please Specify)"
 - **Other funder text box:** Enter into the open text field the code listed for their program in the "Other Funder Code" column (see <u>Table 3</u>).
- **Grant Identifier:** Enter the Grant ID in the format specified in <u>Table 3</u> for the applicable program. A list of assigned grantee IDs for each program can be found in the Appendix to this document.

Multiple Funding Sources

For projects that receive multiple types of funding from state departments, a separate funding source record with the applicable funder code and grant identifier for each funding program must be entered into HMIS. Projects that receive funding from multiple HHAP or HCD contracts should enter multiple funding source records.
