State Funding and Programs Working Group

Racial Equity Data Recommendations

The five recommendations for the **coordinated collection and use of racial equity data** advance the state's commitment to equity, system coordination, and administrative efficiency for funding recipients

When implementing housing and homelessness funding, Council member departments and agencies should:

1. Adopt a public statement explaining why demographic data is collected and how it will be used at the state level
2. Use consistent categories to collect data about race and ethnicity
3. When requesting data on program-level outcomes, make disaggregation by race, ethnicity, and other demographic variables the norm
4. Ask for qualitative data to contextualize required quantitative data
5. Resource equity efforts by investing in technical assistance and capacity-building needs

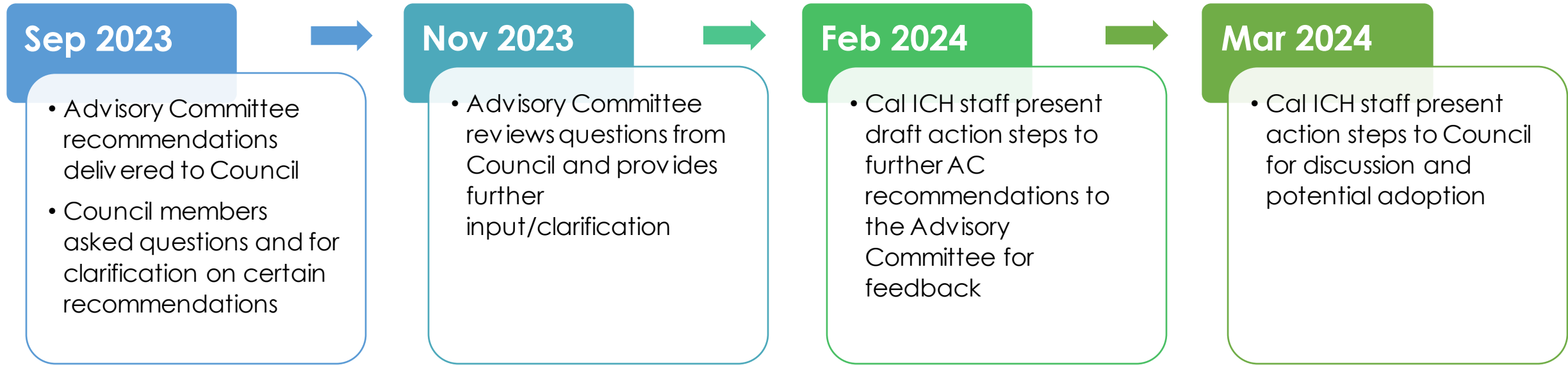

Proposed Action Steps

Proposed Action Steps

Direct the **State Funding and Programs Working Group** to:

- Create recommendations on standard funding application questions, reporting requirements, outcomes, and definitions to help unify state funding applications as much as possible.
- Create recommendations on the ways state programs can design funding requirements to reduce administrative barriers to communities (e.g. funding application and allocation timelines, multiple reports, capacity building, addressing conflicting policies, aligning definitions and requirements) based on Working Group and Advisory Committee recommendations.
- In partnership with the Racial Equity Working Group (REWG), review common contract requirements that create barriers for small, rural, and Tribal communities. Create recommendations to alleviate those barriers.
- Identify opportunities within existing funding to compensate people with lived experience of homelessness in a peer support or advisory capacity.

Direct the **Racial Equity Working Group** to:

- Identify opportunities for smaller organizations to receive guidance or mentorship from more established entities in funding applications, including identifying the right balance of Technical Assistance opportunities for various local jurisdictions (e.g. large urban areas versus smaller or rural communities and new providers).

Proposed Action Steps

Direct the **Lived Experience Advisory Board** to:

- Create best practices for including people with lived experience of homelessness within homeless services programs.

Direct **Cal ICH staff** to:

- Create a central location for all state homelessness program information including funding and timelines, tasking Council departments and agencies to provide updated information to that source.
- In partnership with REWG, identify Technical Assistance opportunities focused on specific populations (e.g. smaller communities, Tribal entities, BIPOC communities) and make that information publicly available in a central location.
- Create a best practices document for working with Tribal entities, including grantmaking and data collection.
- Summarize existing research on service needs and costs for individuals with complex health conditions and best practices to support housing stability and improve health outcomes.

Note: The Advisory Committee also provided recommendations on funding length and design outside the purview of the Interagency Council and therefore will not be voted on

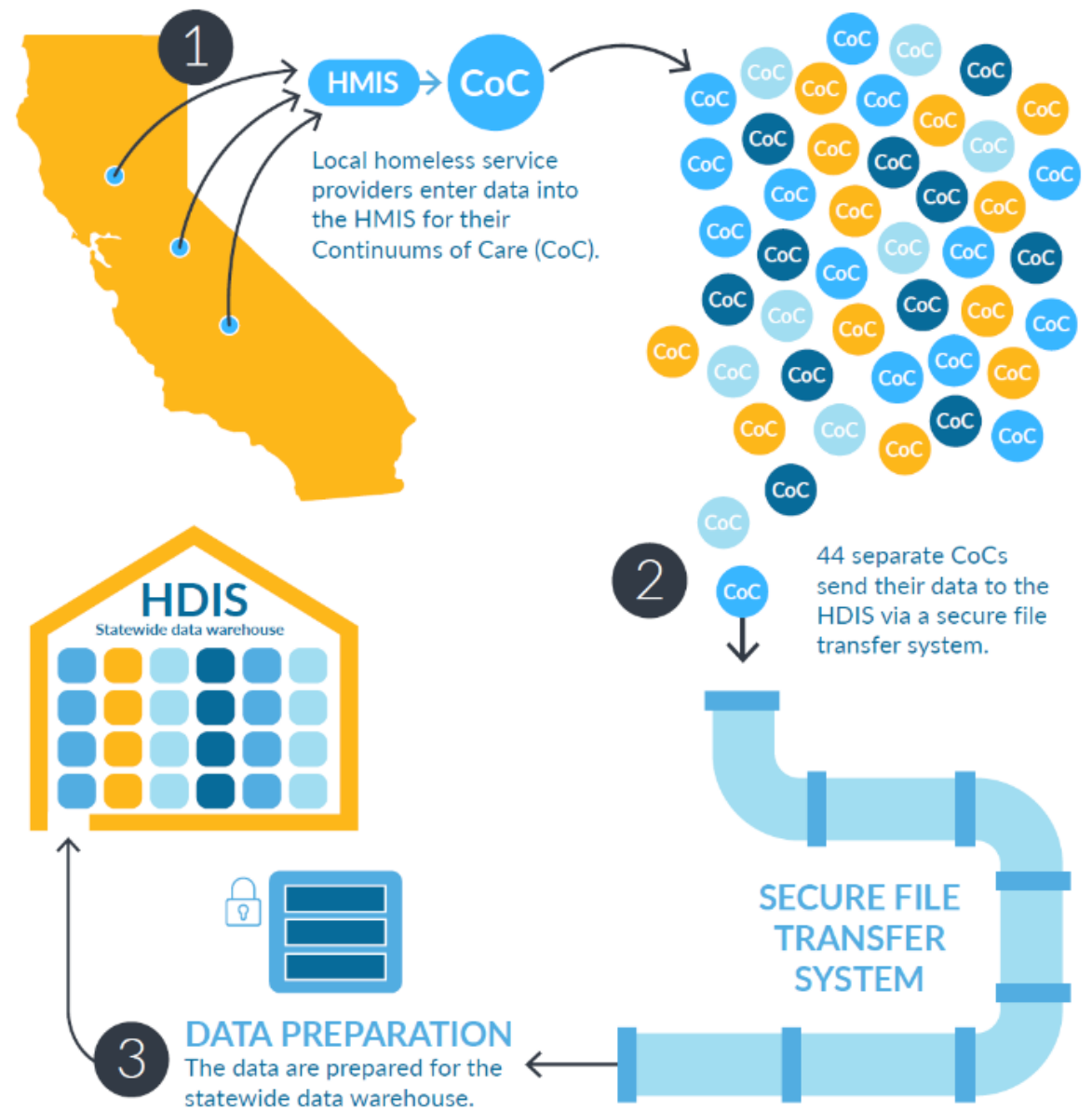

VI. Homeless Data Integration System (HDIS) Overview

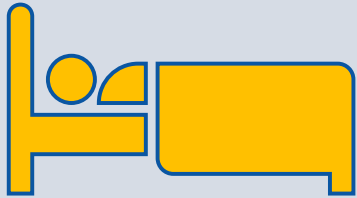
What is HDIS?

HDIS compiles data from California's local homelessness response systems (Continuums of Care) about the people served through programs such as emergency shelter, homelessness prevention, street outreach, and permanent housing interventions



What data is in HDIS?

PROJECTS



Data about the **projects** in a community serving people at-risk of or experiencing homelessness

PEOPLE



Data about the **people** accessing services in a community, and their housing needs

ENROLLMENTS



Data on the projects people are **enrolled** in to receive housing or services to help prevent or end their homelessness

How can HDIS be used to prevent and end homelessness in California?

1

Measuring progress towards implementing the Action Plan and holding the state and local jurisdictions accountable for their commitments

2

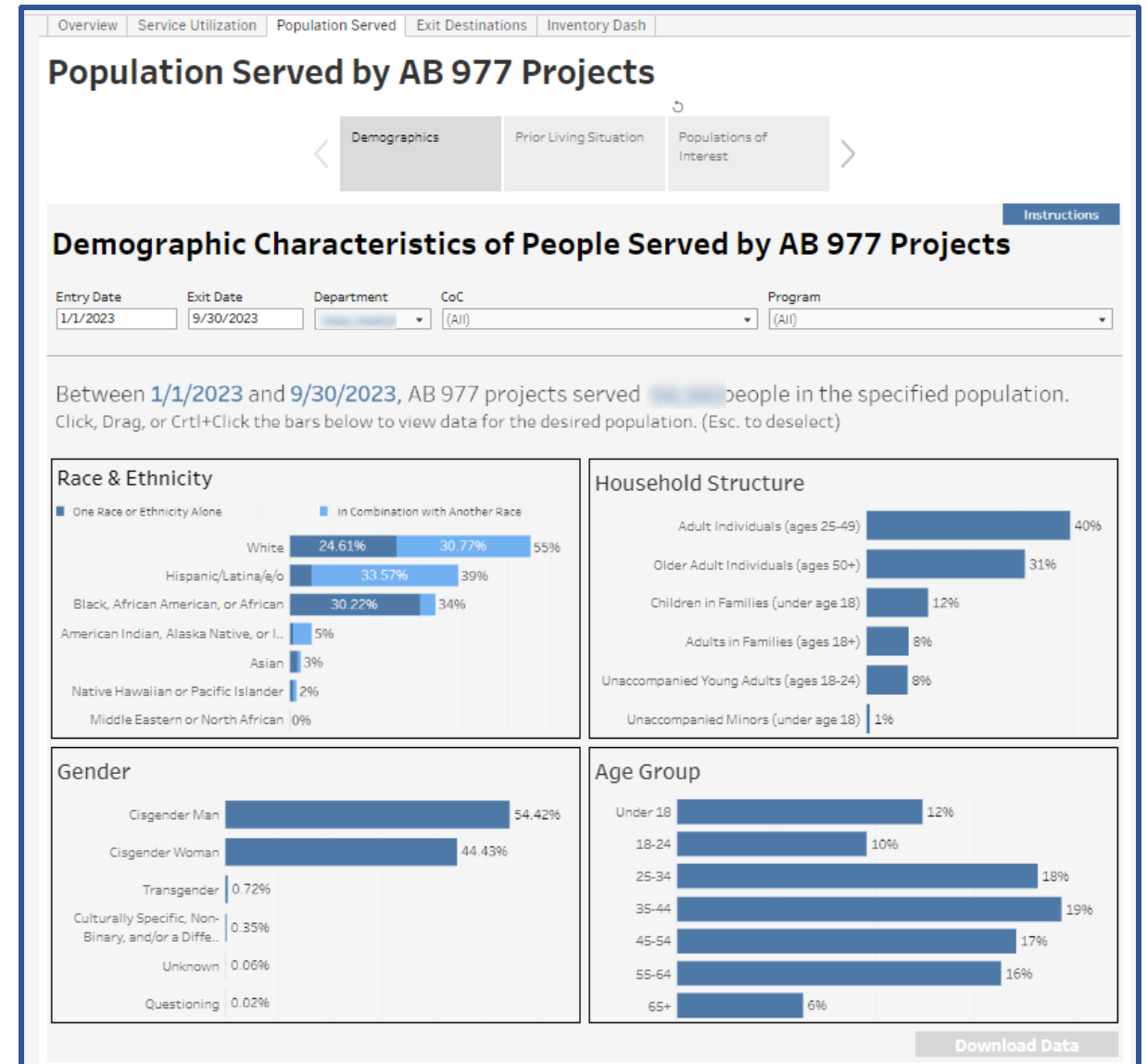
Taking a data-informed, intersectional approach to understanding and **addressing disparities** in which Californians are experiencing homelessness

3

Analyzing the effectiveness of state funding programs and **designing programs** to better meet the needs of people experiencing homelessness

Example 1: AB 977 Dashboards

- AB 977 (2021) requires specified state funded homelessness programs to report into HMIS
- Results in a more comprehensive understanding of the impacts of state funded homelessness programs
- Cal ICH developed dashboards to report data back to administering state departments

Example 2: California System Performance Measures (CA SPMs)

The CA SPMs are a series of metrics developed by Cal ICH to help the state and local jurisdictions assess their progress towards preventing, reducing, and ending homelessness

of people accessing services while **experiencing homelessness**

of people accessing services who are **experiencing homelessness for the first time**

of people **exiting homelessness into permanent housing**

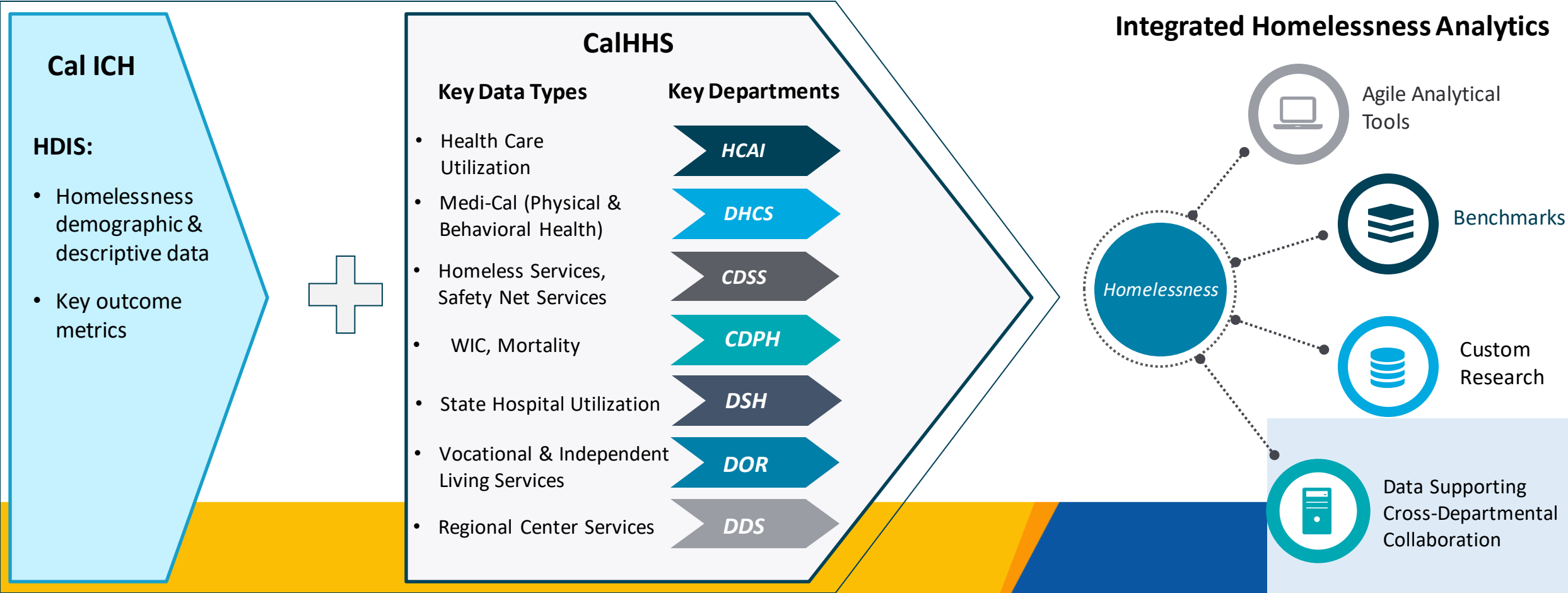
Average **length of time people are homeless** while accessing services

% of people who **return to homelessness** within six months of exiting homelessness to permanent housing

of people with **successful placements from street outreach** into temporary or permanent housing

CalHHS Homelessness Data Integration

Goal: to integrate HDIS data with data from CalHHS departments to provide a more comprehensive, person-centered view to help inform policies and programs addressing homelessness.



Interdepartmental Data Partnership and HDIS Utilization

Key Questions for HDIS / CDSS Data Analysis

- What is the rate of housing instability and homelessness amongst individuals and families engaged in the social safety net?
- Are there differences in service utilization, program need, and program impacts across demographics?
- What portion of clients return to homelessness after program exit?
- How do outcomes compare across programs?



Potential Action Steps Based on Findings

Identify unmet needs amongst social service recipients and opportunities for system integration as related to housing and homelessness services

Evaluate and update program policies and procedures to improve equity and launch targeted TA to address gaps

Target TA resources and refine program guidance to improve impact and expand upon program practices that are demonstrated to be effective

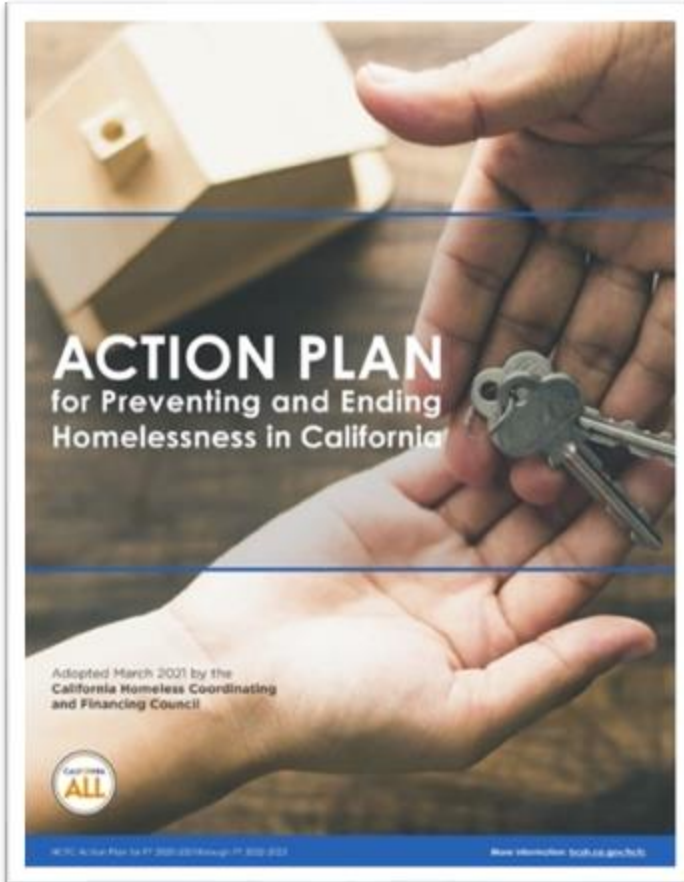

Current Action Plan

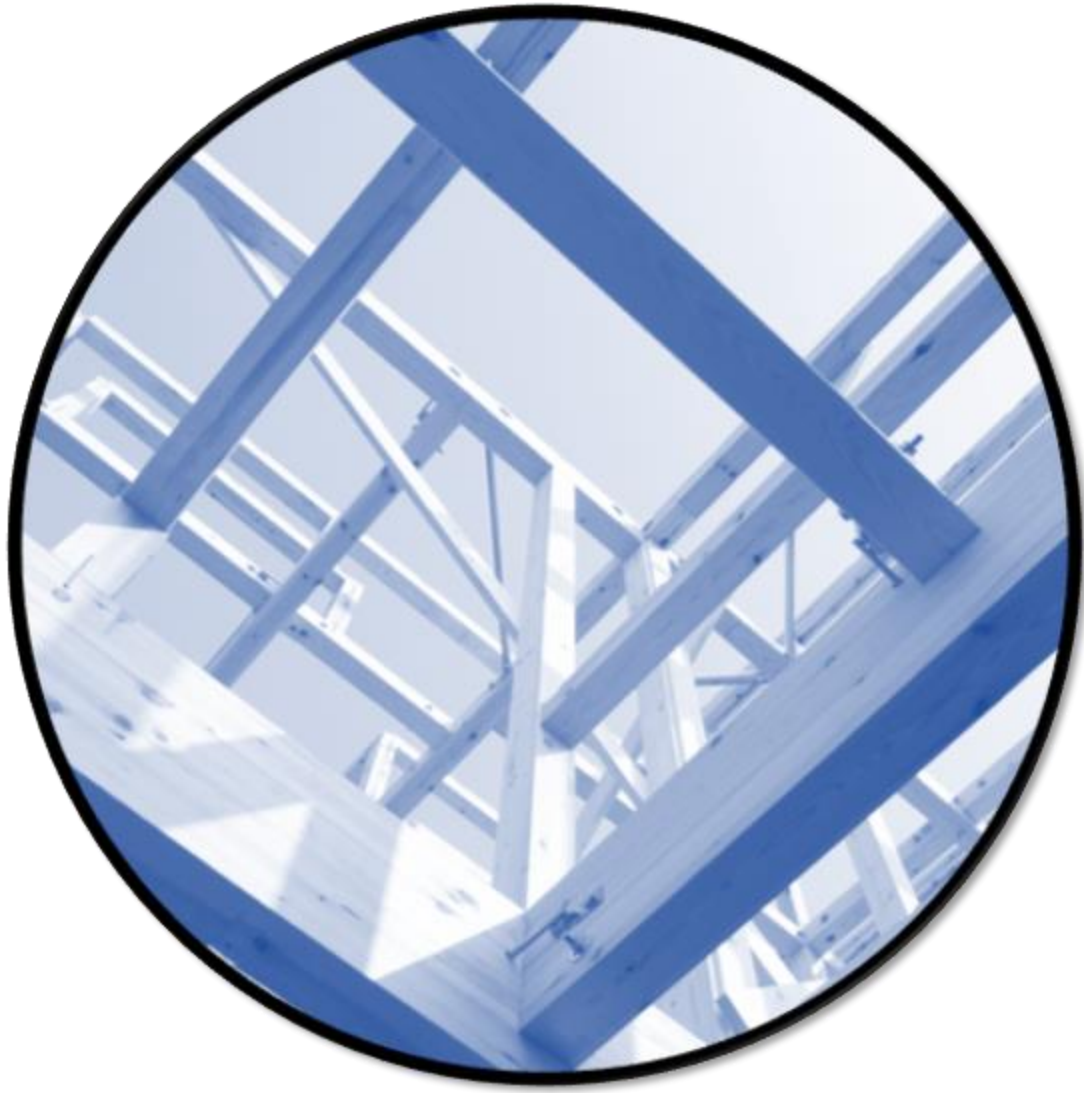


- **Comprehensive collection of State activities** to address homelessness
- Plan covers **FY 20-21 through FY 23-24**
 - Annual progress reports
- **Vision**
 - Homelessness is rare, brief, and one-time
 - Increased leadership from the State
 - Purposeful, action-oriented coordination and alignment
 - Stronger, collaborative partnerships
- **New plan to cover FY 24-25** and beyond

High-Level Revision Timeline

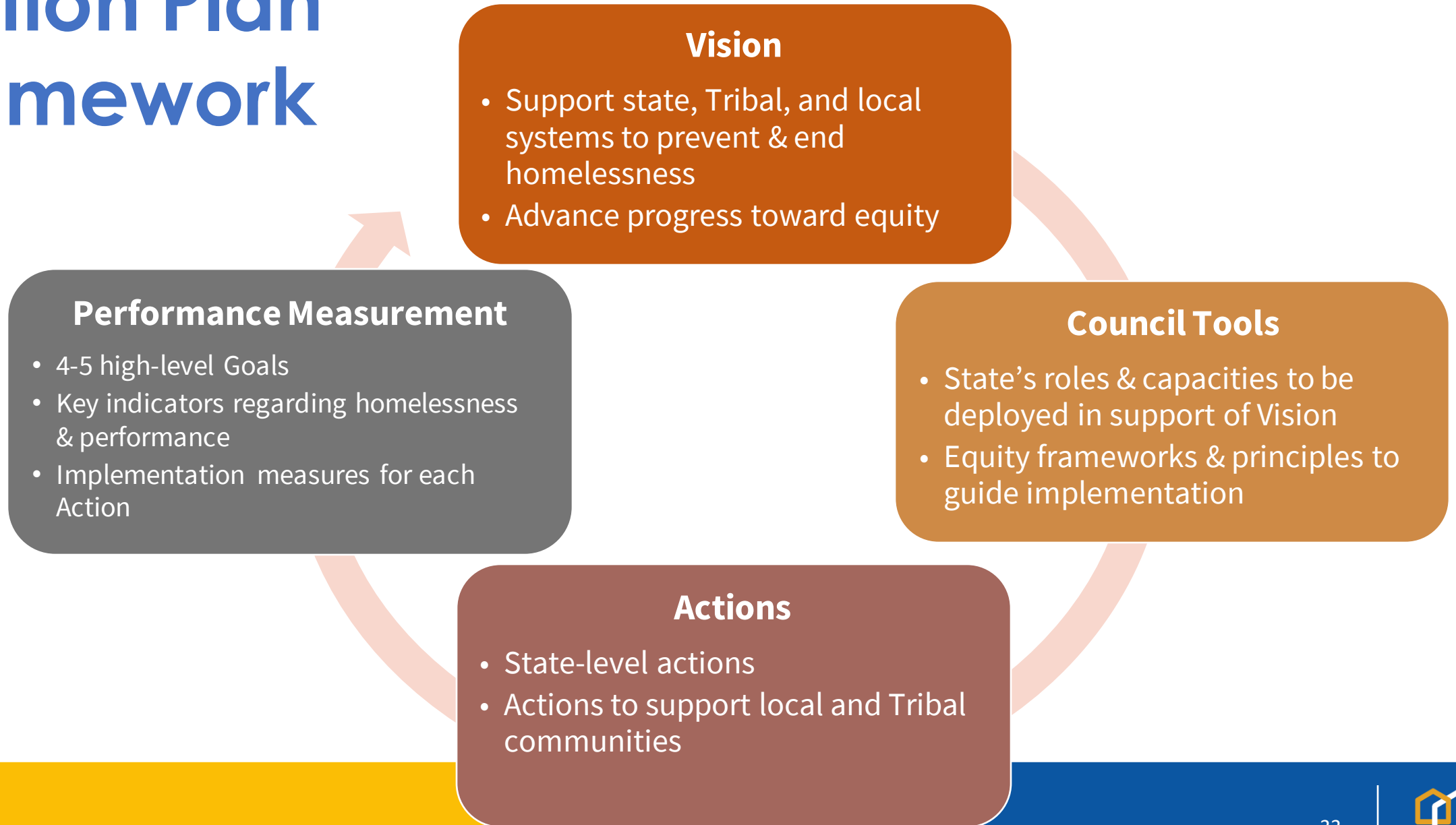

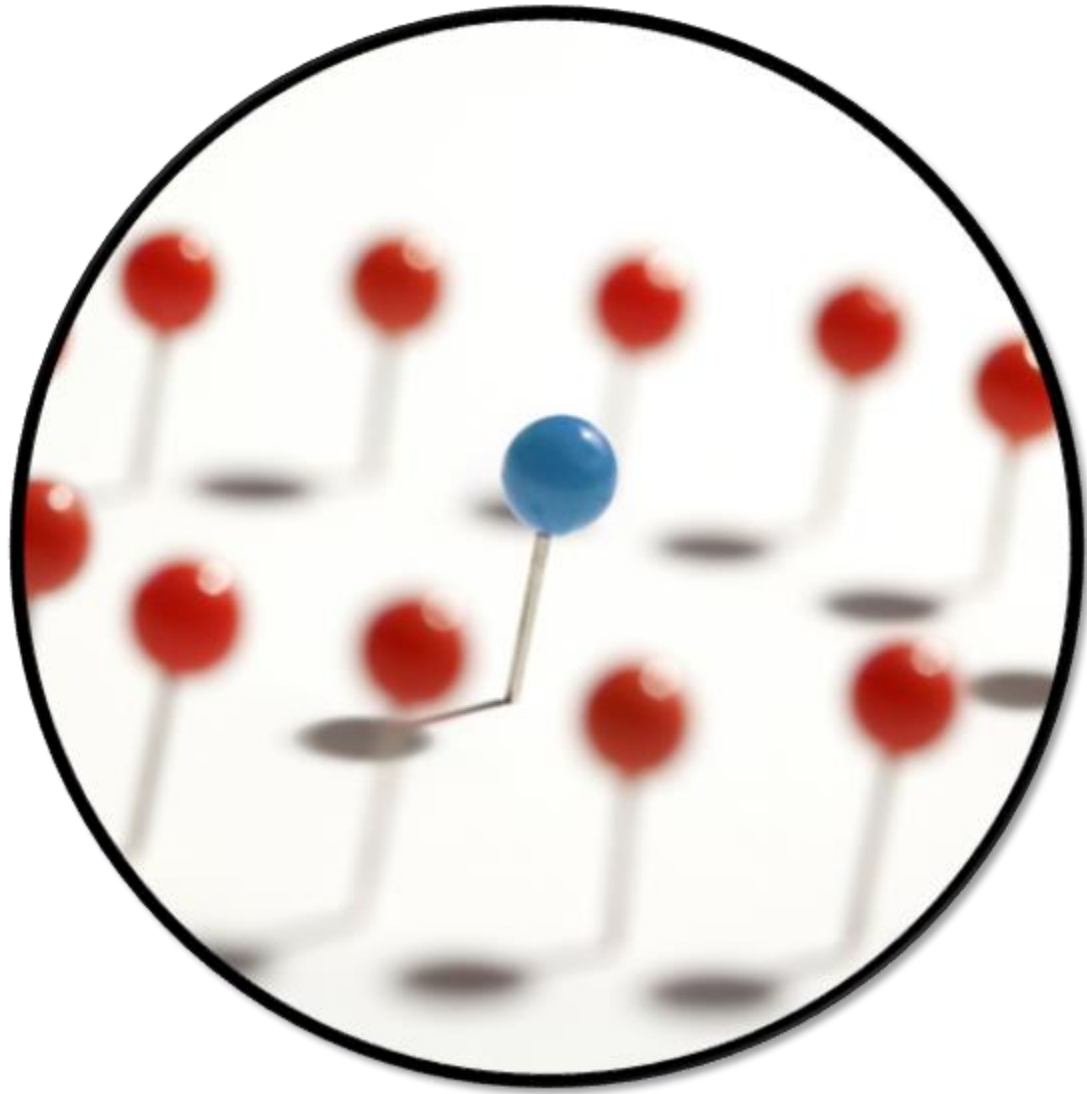

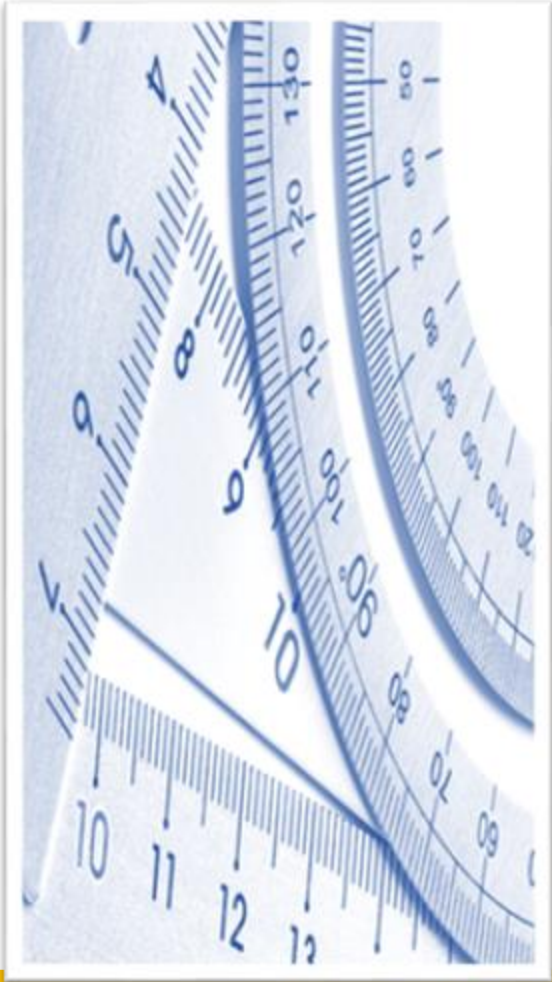

Proposed Action Plan Goals

Performance Measurement



- **High-level Goals (4-5) the Plan will strive to achieve** and how they will be measured, tracked, and reported (more below)
- **Key Indicators** to provide supplemental information regarding homelessness response systems in CA
- **Individual implementation measures** to understand success of each Action
 - Clear connection between the Actions in the Plan and the high-level Goals

Action Plan Goals

Current Plan does not identify any explicit Goals

- Identifies Key Performance Measures, aligned with the California System Performance Measures (CA SPMs)

New Action Plan proposes using CA SPMs to create a **set of directional goals**

Current Plan's Key Performance Measures

- **Number of Californians experiencing homelessness**, including Veterans, people experiencing chronic homelessness, families with children, adults, and unaccompanied youth.
- Number of Californians **experiencing homelessness for the first time each year**.
- Number of Californians successfully **exiting homelessness into permanent housing** each year.
- Average length of time Californians are **remaining homeless while accessing services**.
- Percent of Californians **returning to homelessness after exiting homelessness to permanent housing** each year.
- Number of Californians **successfully placed from street outreach** into emergency shelter, transitional, or permanent housing each year.
- Number of **children and youth experiencing homelessness at some point during the school year** in California, including students in families and unaccompanied students.
- **Comparison of California's performance** across these measures to national and regional trends as well as by race and ethnicity.

Criteria for Goals

*To be included in the new Action Plan, **Goals must meet the following criteria:***

- **Represent core outcomes that homelessness response systems must accomplish** to prevent and end homelessness
- **Help focus the Council** on actions that will drive progress
- **Help public understand** focus of efforts
- **Can be consistently and effectively measured** over time

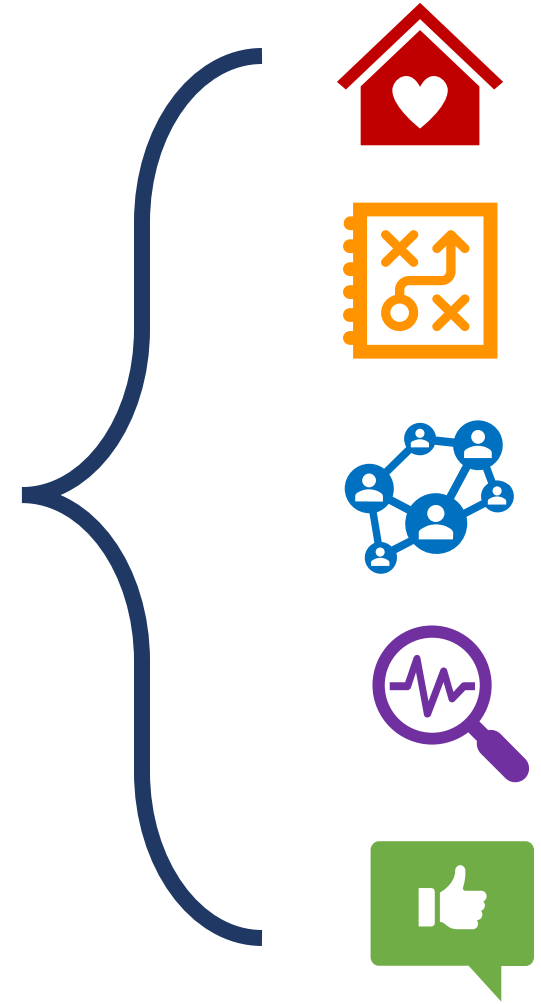
By implementing these Actions, the State will be striving to achieve the following draft Goals:

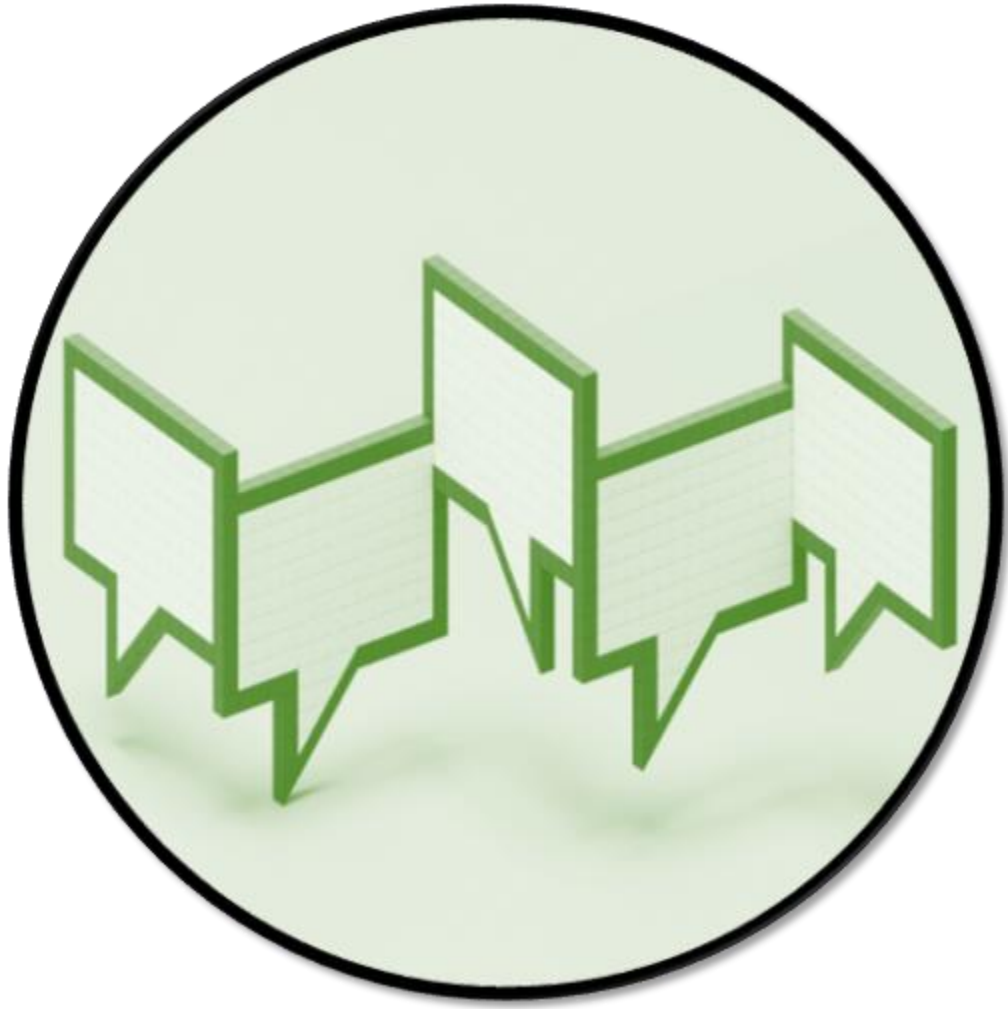
1. Increase the number of people exiting homelessness into permanent housing
2. Reduce the length of time people remain homeless
3. Reduce the number of people returning to homelessness after exiting to permanent housing
4. Increase successful placements from street outreach

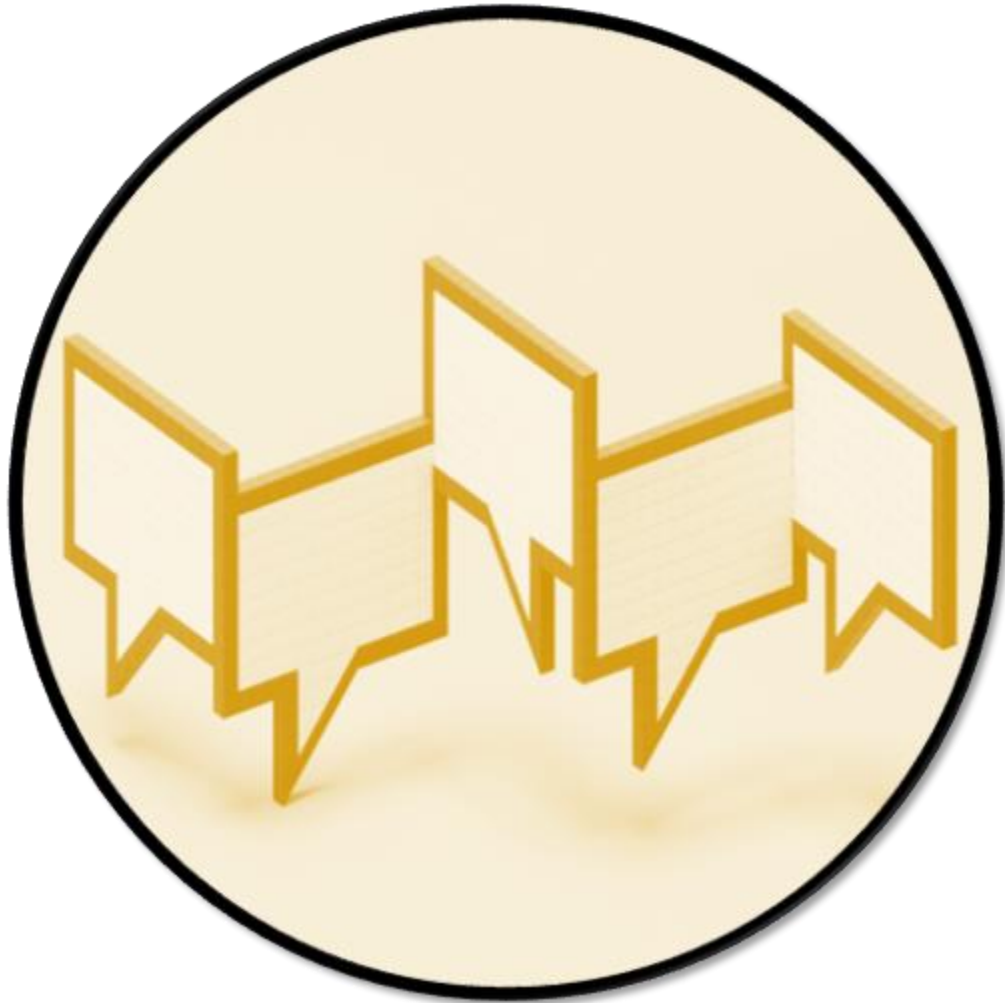
