Mission: Cal ICH is a statewide facilitator, coordinator, and leader for policy development and research for state, local, and Tribal partners in their work to prevent and end homelessness in California.

Vision: Cal ICH is motivated by a vision of a future in which homelessness is rare, brief, and a one-time experience in order to prevent and end homelessness in California.

The autonomy and self-determination of California's Tribes in addressing homelessness in their communities






VII. Action Plan Public and Tribal Input

High-Level Timeline

April - August

- Public and Tribal listening sessions
- Strategy and planning discussions with Council agencies and departments



September - November

- Finalize Plan content and department commitments
- Develop dissemination strategy

- Propose new Action Plan to Council for adoption

Themes from Input Provided

A consistent focus on addressing racial disparities in homelessness within State programs, including a focus on the specific needs of Tribal communities.

- Include a Tribal representation on the Council and/or a Tribal working group
- Include actionable tools to analyze the effectiveness of equity within programs
- Create accountability measures to ensure overrepresented populations in homelessness are prioritized in service provision

Themes from Input Provided

Urgently increasing permanent housing supply in order to provide pathways out of homelessness.

- Remove barriers to rapidly deploy funding for the development of new housing
- Consider funding non-traditional housing options

Themes from Input Provided

Ongoing, flexible resources to be able to support a range of program models that meet the variety of needs of people experiencing homelessness.

- Use HHAP as a model for program flexibility
- Allocate funding for historically un-funded work, such as HMIS licenses and data entry training
- Re-examine the use of PIT data for funding allocations

Themes from Input Provided

Significant and meaningful inclusion of people with lived experience in State-level decision making.

- Provide opportunity to inform the utilization of Prop 1 funding
- Require and/or incentivize inclusion of people with lived experience in program design within funding applications
- Incorporate feedback opportunities while people are in programs. Including measures of success that assess a persons' overall wellbeing

<u>Themes from Input Provided</u>

Streamlining requirements and processes to help address the administrative challenges communities are facing.

- Keep funding applications and reports consistent across multiple years
- Discourage use of HUD-ESG reporting requirements as best practice, considering the complexity and difficulty for providers to obtain payment through this program
- Establish a uniform HMIS/data system or baseline system requirements across all counties
- Strengthen reporting of employment services provided to, and employment outcomes achieved by, people experiencing homelessness and people participating within housing and services programs.



Themes from Input Provided

Investing in the skills, wages, and capacity of the workforce within homelessness response and housing programs.

- Require harm reduction and trauma-informed care training for all staff and measure utilization of these practices
- Create more opportunities for peer support positions within programs
- Create a workforce pipeline with education systems

Themes from Input Provided

Guidance and support to align housing strategies with health and behavioral health strategies to reach vulnerable populations and increase impact.

- Integrate social support groups within programs to bolster social connections and healthy relationships
- Increase communication between health, behavioral health, and social service programs to decrease barriers to access
- Expansion of the In-Home Supportive Services (IHSS) program within homeless services programs

Themes from Input Provided

Preventing homelessness among people re-entering communities from hospitals, jails, prisons, and other institutional settings.

- Prevent people exiting state-systems into homelessness
- Work with housing insecure students to connect to housing before graduation
- Provide targeted funding for specific subpopulations that experience homelessness at disproportional rates (e.g. people exiting incarceration, child welfare, health care, etc.)
- Ensure service and health care access of the above populations



Themes from Input Provided

Interest in the state engaging in expanded communications and educational efforts to help support effective solutions in local communities.

- Communicate causes of homelessness and responsibility for preventing homelessness clearly and accurately ("People don't blame firefighters for the fires they put out.")
- Create a group to coordinate all State housing and homelessness communications
- Debunk myths surrounding homelessness and combat NIMBY-ism
- Encourage legislators and the administration to engage with the communities they serve to understand what the needs are, what resources are available, and what interventions are effective

Tribal Consultation & Input

Background



Meaningful Tribal inclusion in programs and policies that impact Native Americans

- Executive Order N-15-19
- Agency and Department Tribal Consultation Policies.
- The incorporation of the needs and voices of Tribal Communities ensures that program and policy interventions designed to meet the needs of Tribal Communities are meaningful, culturally appropriate, and effective.


Methods of Tribal Consultation

- Dear Tribal Leader Letters to all California Tribes inviting formal consultation
- Regional, hybrid listening sessions hosted in partnership with Tribes and Tribally Designated Housing Entities
- Meetings with the Cal ICH Tribal Liaison
- Survey
- Tribal feedback has not been censored by Cal ICH



March 29, 2024, Tribal Listening Session with Tribal Leaders and Cal ICH in Pala, California.

Call for Action



- Tribal Communities are in crisis
- The "status quo" perpetuates this
- Time for purposeful and bold action, different than how the state typically does business
- California Tribes face rates of homelessness up to 50%
- California Tribes do not have a seat at our table, nor access to adequate and accessible funding

Tribal Needs, Voices, and Best Practices

- Tribes are not BIPOC, they are sovereign nations
- Tribal Leaders would like the Council to regularly address tribal issues
- Both Federally Recognized Tribes and Tribes that have not yet been recognized require inclusion in the Action Plan



Tribal Needs, Voices, and Best Practices



- Lack of understanding of the needs, circumstances and best practices of Tribal Communities
- State, local governments, and others in the homelessness arena require education
- Requirements to work with Tribes in local and other homelessness solutions
- Uplift tribal expertise
- Having adequate housing in Tribal Communities is key to their safety, healing, stability, and preservation



Tribal Needs, Voices, and Best Practices

- Tribal Liaisons placed in Executive Offices to inform, educate, and coordinate implementation of tribal needs and expertise
- Improved tribal engagement and relationship building
- Tribes face racism, discrimination from businesses, "upcharging," intimidation, death threats, and more when progressing homelessness interventions
- Uplifting tribally-informed best practices and tribal inclusion in local and state coordination is key

Streamlining & Coordination



- Forum to regularly engage to share information and cocreate solutions with the state
- Improved coordination across state and local practices and amongst tribal liaisons
- Utilization of culturally appropriate, meaningful approaches – uplift tribal expertise
- Communication and programs across the state must "speak the language of Tribes"
- Tribes have limited capacity

Access to Funding

- State programs rarely created for or with Tribes
- Majority of Tribes cannot access most state funding opportunities
- Cal ICH's Tribal HHAP was cited a best practice
- Increase amount of flexible funding

- Decolonize, focus on relationship, a "more human" touch
- Stop disenfranchising Tribes in current programs and practices
- Examples:
 - Definition of "evidence-based practices" that excludes Tribal adaptations
 - Grant thresholds that require housing development experience



Tribal Data



- Current data does not include Tribes.
 Homelessness is worse than cited in current data sources
- CA Native Americans have the highest disparities of homelessness in the state
- Data solutions begin with meaningful engagement and co-creation of solutions
- Tribes are denied a seat at the table of state and local orgs due to the small population size caused by their genocide and colonization

Conclusion



California Tribes and Tribal Communities need equity and consideration of the government's role in their current circumstances, rather than being an afterthought in homelessness policy and program solutions.
