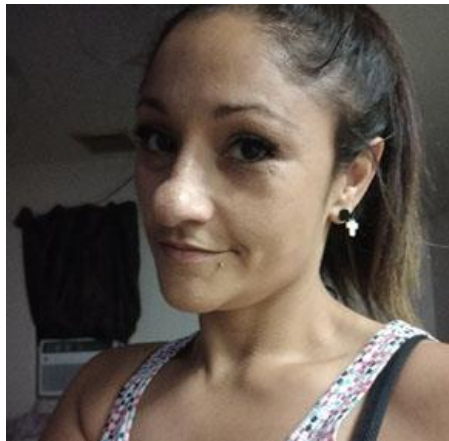

Vision

An equitable and just California in which homelessness is rare, brief, and never more than a one-time experience.

Guiding Principles and Commitments

- Pursuing racial equity and justice
- Creating solutions for the full diversity of people experiencing homelessness
- Seeking and valuing the expertise of people with lived experiences of homelessness
- Strengthening Housing First approaches
- Balancing crisis response and permanent housing solutions
- Advancing trauma-informed care and person-centered services
- Aligning health, housing, and homelessness strategies
- Increasing access to resources for California's Tribal communities

Goals: What Data is in HDIS?

PROJECTS



Data about the **projects** in a community serving people at-risk of or experiencing homelessness

PEOPLE



Data about the **people** accessing services in a community, and their housing needs

ENROLLMENTS



Data on the projects people are **enrolled** in to receive housing or services to help prevent or end their homelessness

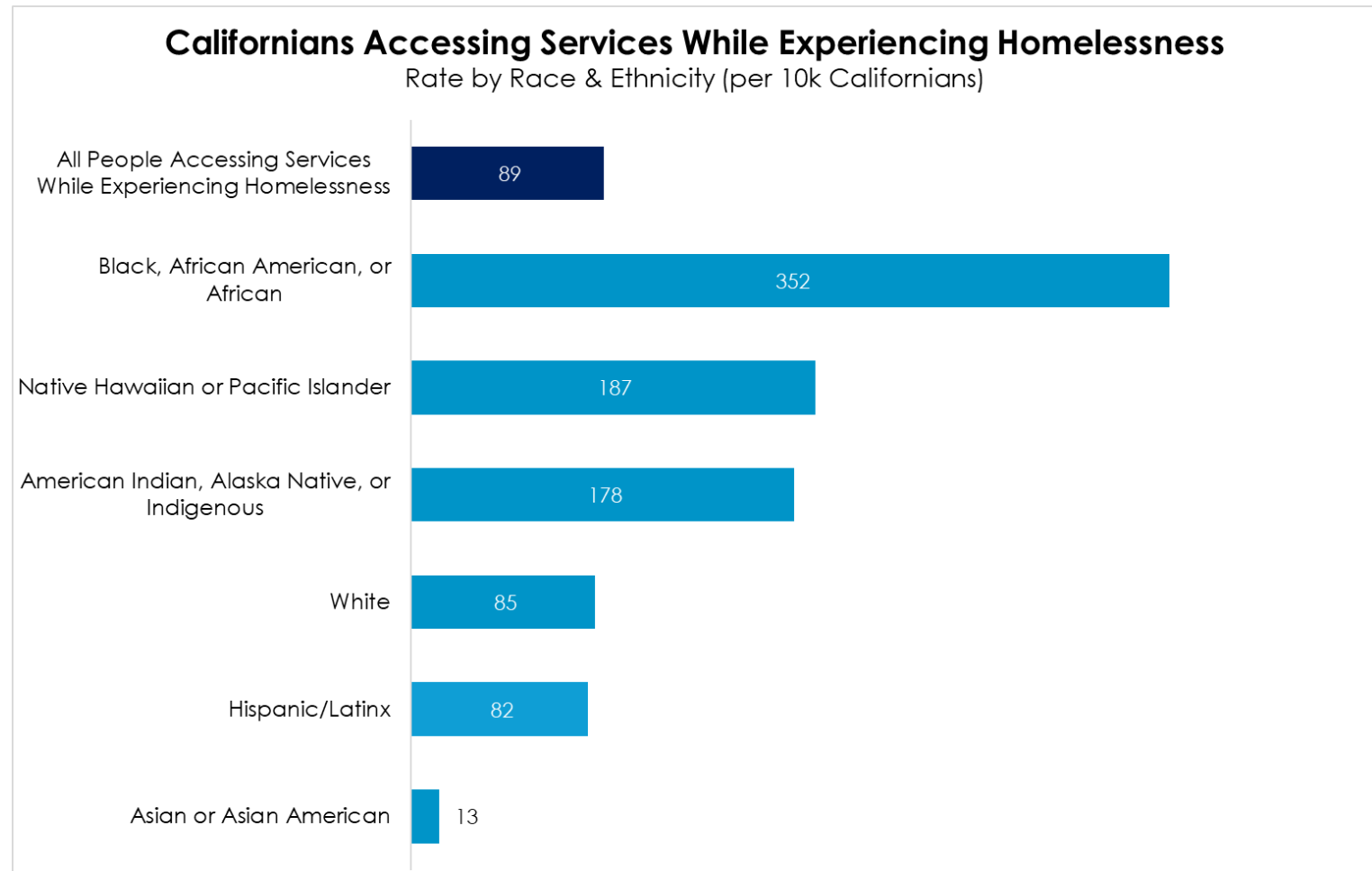
Baseline Data: Homelessness in California

Measure	FY 2022-2023	Change from Previous Year
# of People Accessing Services While Experiencing Homelessness	349,519	+17%
# of People Experiencing Homelessness for the First Time	184,334	+13%
# of People Exiting to Permanent Housing	72,298	+14%
Average Length of Time Homeless (Days)	156	+1%
% of People Returning to Homelessness	9.10%	-0.02 percentage points
# of People Successfully Placed from Street Outreach	11,748	+7%

Racial and Ethnic Disparities in Homelessness

This chart shows the number of people in each group who are **accessing services** while experiencing homelessness, relative to their share of California's overall population.

- Out of every **10,000 people** in California, **89** accessed services while experiencing homelessness during FY 22-23.
- Out of every **10,000 Black, African American, or African people** in California, **352** accessed services while experiencing homelessness
- That means **3.52% of all Black, African American, or African people** experienced homelessness that year

<p>2. [Exploring] Reduce inflow into homelessness: Reduce the ratio of people entering homelessness as compared to those exiting each year to XX.</p> <p><i>Specific inequities to be redressed might include:</i></p> <ul style="list-style-type: none"> • Racial inequities experienced by Native American and Black communities in continuous experiences of homelessness from year to year. • Risks of homelessness and access to prevention resources within Native American and Black communities. • Disparities in housing referrals and successful permanent housing placements within Native American and Black communities. 	<p>Ratio - 1:3.7 for every 10 people who exited homelessness, 37 people entered or returned to accessing homeless services.</p>

Help more people leave unsheltered homelessness: Increase by XX% the total number of people who leave unsheltered homelessness to either emergency shelter, interim housing, or permanent housing.</p> <p><i>Specific inequities to be redressed might include:</i></p> <ul style="list-style-type: none">• Overrepresentation of Native American and Black communities among those who are unsheltered.• Disparities in access to services, interim and permanent housing options, and outcomes achieved for Native American and Black communities.	<p>92,976 people who were experiencing unsheltered homelessness moved into a sheltered setting.</p>
<p>4. Help more people move into housing: Increase by XX% the total number of people who move into permanent housing.</p> <p><i>Specific inequities to be redressed might include:</i></p> <ul style="list-style-type: none">• Racial inequities experienced by Native American and Black communities in lengths of time remaining homeless while accessing services and in continuous experiences of homelessness from year to year.• Disparities in housing referrals and successful permanent housing placements among Native American and Black communities.	<p>72,298 people exited homelessness and moved into permanent housing.</p>

- 2. [Exploring] Reduce inflow into homelessness:** Reduce the ratio of people entering homelessness as compared to those exiting each year to XX.
- 3. Help more people leave unsheltered homelessness:** Increase by XX% the total number of people who leave unsheltered homelessness to either emergency shelter, interim housing, or permanent housing.
- 4. Help more people move into permanent housing:** Increase by XX% the total number of people who move into permanent housing.

Cal ICH Statutory Obligations

The council shall have all of the following goals:

- (1) To oversee implementation of this chapter.
- (2) To **identify** mainstream **resources, benefits, and services** that can be accessed to prevent and end homelessness in California.
- (3) To **create partnerships** among state agencies and departments, local government agencies...
- (4) To **promote systems integration** to increase efficiency and effectiveness while focusing on designing systems to address the needs of people experiencing homelessness...
- (5) To **coordinate existing funding and applications** for competitive funding...
- (6) To make **policy and procedural recommendations** to legislators and other governmental entities.
- (7) To **identify and seek funding opportunities** for state entities that have programs to end homelessness...
- (8) To **broker agreements** between state agencies and departments and between state agencies and departments and local jurisdictions **to align and coordinate resources, reduce administrative burdens of accessing existing resources**, and foster common applications for services, operating, and capital funding.
- (9) To serve as a **statewide facilitator, coordinator, and policy development resource** on ending homelessness in California.
- (10) To **report** to the Governor, federal Cabinet members, and the Legislature on homelessness and work to reduce homelessness.
- (11) To **ensure accountability and results** in meeting the strategies and goals of the council.
- (12) To identify and implement strategies to fight homelessness in **small communities and rural areas**.
- (13) To create a **statewide data system or warehouse**, which shall be known as the Homeless Data Integration System...
- (14) To **set goals to prevent and end homelessness** among California's youth.
- (15) To improve the **safety, health, and welfare of young people** experiencing homelessness in the state.
- (16) To increase system integration and coordinating efforts to prevent homelessness among **youth who are currently or formerly involved in the child welfare system or the juvenile justice system**.
- (17) To lead efforts to coordinate a spectrum of funding, policy, and practice efforts related to **young people experiencing homelessness**.
- (18) To identify best practices to ensure **homeless minors** who may have experienced maltreatment...
- (19) To collect, compile, and make available to the public **financial data provided to the council from all state-funded homelessness programs**.

What the Action Plan Does

- Communicates the State's vision for preventing and ending homelessness
- Creates and monitors Goals to achieve over the course of three years
- Aligns State work on homelessness around common Tools
- Identifies and sets priority activities for Council departments and agencies to work on in service of our Goals

What the Action Plan Does Not (Currently) Do

- Explicitly set funding priorities
- Provide policy recommendations to the legislature or the Governor's Office
- Hold specific programs accountable to performance metrics
- Assess overall collaboration across Council members
- Provide training/guidance on relevant topics

ICH Work in Other States

- Minnesota:
 - ICH collective budgeting
 - Community implementation of Action Plan
- Maine:
 - Communications committee prepares press releases, cultivates media relationships, distributes materials, etc.
- Arizona:
 - Funding decisions for \$150 million Housing Trust Fund via listening sessions across the state
